## Recovery Day Art Show Contest Consent Agreement

- 4) I understand, consent, and agree that CRSI, in its sole and unfettered discretion, has the right to amend the categories of the exhibition for any reason whatsoever.
- 5) I hereby consent to the exhibition and/or publication by CRSI, its agents, and/or designees of the art submitted.
- 6) I hereby consent to CRSI posting on its website and/or publication of my name, my photograph, and of the art submitted by me.
- 7) I understand, consent, and agree that CRSI, in its sole and unfettered discretion, has the right to reject the art submitted for exhibition for any reason whatsoever, including, but not limited to depiction of inappropriate content such as ridicule, nudity, pedophilia, pornography, or offensive or graphic violence.
- 8) I agree to pick up or make other arrangements for the return of the art submitted and to be solely responsible for the cost(s), if any, for the return of the art. I further agree that if I fail to pick up the art submitted by October 16, 2015, CRSI, in its sole and unfettered discretion may display or dispose of the art in any manner whatsoever.
- 9) I agree to and hereby hold harmless CRSI, its employees, volunteers, agents, and/or assignees from any present or future claim arising out of or involving the art submitted and further agree to indemnify CRSI for any loss, claim, or expense incurred hereby.
- 10) I release CRSI from any and all responsibility, costs or expense arising from any loss, theft, damage, destruction, or vandalism of the art submitted.
- 11) I authorize CRSI to refer to me as a "Person in Recovery" or use my full name and/or my photography in any release or statement pertaining to the art submitted for exhibition, or in any award, release, or statement pertaining to the exhibition.
